Council Meeting May 16, 2023, 6:00 PM

A. Called to Order

Having a quorum, the Regular Council meeting was called to order by **Council President Raymond Doherty** at 6:00 PM. **Mayor Randy Gawith** was absent. Council members present were **Councilor Rhonda Lazinka**, **Councilor Tegan Kaneaster**, **Councilor Tiffany Schademan and Councilor Vern Sandy**. Councilor **Derek Turner was absent**. Department Heads present were **City Recorder Teri Bacus**, **Public Works Director Tim Britain and Chief of Police William Caldera**. Corporal Daniel Badal from the Police Department also attended. Citizens that attended were Mike Lankford, Ray Bacus, Jackie Carey, Blaze Basye, Lyndie Basye, Karen Stanton, Katie Weinke, Randall Smith, Lillie Hoiman, Deborah White, Ashly Staggs and Michael Staggs.

Pastor Randal Smith gave the invocation.

C. PLEDGE OF ALLEGIANCE

D. APPEARANCE OF INTERESTED CITIZENS

Mike Lankford addressed City Council as a representative from the Pilot Rock Parks and Recreation District. City Recorder explains that he brought to her attention a drainage issue above the community center. The inadequate draining is creating a large mud area in the parking lot. She provided pictures that show the two roads above needing repair. Public Works Director Tim Britain explains how the repairs would divert the water which would end up in the creek. Councilor Doherty states that it looks like to him, it's the way to fix it. The amount in the budget for street repair and the Cherry Street paving grant was discussed. City Recorder states that the Cherry Street grant cannot be used for these repairs. **Councilor Sandy made a motion to authorize Tim to start repairs to fix the drainage issue and Councilor Schademan voted yes. Motion carried: 5 Yes – 0 No**

F. ACTION ITEMS

F-1 Manufactured Home Variance – City Recorder presents a request from property owner Deborah White for a variance on the size of a new manufactured home. City code states that manufactured homes "be multi-sectional (double-wide or wider) and enclose a floor area of not less than 1,000 square feet". The home she would like to place is a single wide with 746 square foot and meets all other requirements including setbacks with an attached carport. City Recorder provides pictures of a single wide manufactured home and explains that it is not a mobile home or recreational vehicle but a new home being manufactured. She also includes the R-2 Limited Residential Zone ordinance for reference and explains that the lot should be 7500 square feet and this older lot is 7334 square feet. Councilor Doherty asks if notification letters were sent to the surrounding neighbors and City Recorder states yes.

She also states that public notices were placed, and an advertisement was in the Eastern Oregonian. There were no responses. Citizen Jackie Carey explains that she believes that it would look a lot better than it does now. She explains her concerns about city council following ordinances that are in place. She is also concerned about the setbacks and City Recorder explains that the appearance is different that the dimensions that are on the plot map and the plan meets all setbacks. She also asks about the planning commission being restarted. She feels that the planning commission is another review to assist in the planning of land use and the appeal process. She states that she is not against this request, but a planning commission would be beneficial to the city council. The lot size and timeframe to rebuild a home that was removed due to fire was discussed. Jackie states that her main concern was a planning commission so that there could be due process. Councilor Kaneaster explains that this topic has already been reviewed and no volunteers were present at the meeting to discuss. Councilor Schademan states that when the planning commission was previously discussed there were only a half a dozen reviews per year which are not that many. She also notes that there was no interest, and the planning commission would be difficult to maintain. Councilor Doherty made a motion to approve the variance for the single-wide home and Councilor Sandy seconded. Councilor Schademan voted ves, Councilor Kaneaster voted yes, and Councilor Lazinka voted yes. Motion carried: 5 Yes – 0 No

F-2 Second Reading Ordinance #597 Dangerous Dog – City Recorder presents Ordinance #597 and reads the ordinance in title only. No public comments were made. Chief Caldera states that this ordinance will assist in the processing of dangerous dogs. **Councilor Lazinka made a motion to approve the second** reading of Dangerous Dog Ordinance #597 and Councilor Sandy seconded. Councilor Doherty voted yes, Councilor Schademan voted yes, and Councilor Kaneaster voted yes. Motion carried: 5 Yes – 0 No

F-3 Resolution #699 Surplus Property/Police Vehicle – City Recorder presents resolution #699 Surplus Property which identifies the two older 2009 and 2010 Ford police vehicles. The resolution authorizes the Chief of Police to advertise and sell the vehicles. **Councilor Doherty made a motion to approve resolution** #699 and Councilor Lazinka seconded. Councilor Kaneaster voted yes, Councilor Sandy and Councilor Schademan voted yes. Motion Carried: 5 Yes – 0 No

F-4 Resolution #700 – City Recorder presents resolution #700 which assigns an address to the newly partitioned industrial property. The property is owned by Hayden Construction and is currently being developed. The resolution assigns the address 800 Circle Road. Chief Caldera comments that the Bike Pit has the address of R A Koch Road. There was discussion on where R A Koch Road begins and ends. Also, where Circle Road and Mill Road begin and ends. **Councilor Kaneaster made a motion to table the address resolution and Councilor Lazinka seconded. Councilor Schademan voted yes, and Councilor Doherty voted yes and Councilor Sandy voted yes. Motion carried: 5 – Yes 0 – No**
